Tracy Dompeling Appointed Deputy Commissioner of the Alaska Department of Family and Community Services

Dompeling brings over 28 years of experience in Alaska public service, including leadership roles in juvenile justice, behavioral health, and statewide systems management. Most recently, she served as Director of the Division of Behavioral Health within the Department of Health, where she led Medicaid reform efforts to optimize provider payment and expand service delivery.

Prior to the 2022 reorganization that created DFCS, Dompeling served as Director of the Division of Juvenile Justice under the former Department of Health and Social Services. In that role, she oversaw statewide juvenile justice operations and collaborated closely with DFCS divisions including the Office of Children's Services, Alaska Pioneer Homes, and the Alaska Psychiatric Institute.

Dompeling holds a Master of Arts in administration of justice and a Bachelor of Arts in social work from the University of Alaska Fairbanks. She is recognized for her collaborative leadership style, transparent communication, and commitment to public service.

"It is an honor to continue serving the State of Alaska as Deputy Commissioner of the Department of Family and Community Services," said Dompeling. "I'm grateful for the opportunity to return to a department so deeply committed to providing support, safety, and personal well-being for vulnerable Alaskans. I look forward to working with the dedicated DFCS team to advance meaningful initiatives and strengthen services that directly impact the lives of those we serve."
