Disproportionate Minority Contact in Alaska



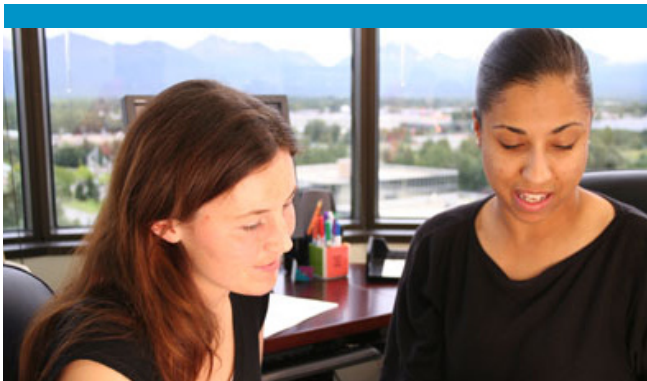
What is Disproportionate Minority Contact?

Disproportionate Minority Contact (DMC) exists when minority youth have a rate of contact with the juvenile justice system that is significantly different from the rate of contact for white youth.

Why Do We Have DMC?

There is no single cause of DMC. It can be created in many ways, including:

- Minority youth may have less access to prevention and treatment services.
- Minority youth may have more involvement in some illegal activities.
- Minority families may have fewer education and job opportunities.
- Communities may have inadequate resources for serving minority youth.
- Agencies may use decision-making criteria with unintended DMC impact.
- Governments may pass laws with unintended DMC impact.

How Does DMC Affect Alaskans?

DMC affects all minority youth in Alaska. In general, the minority groups with the highest DMC rates are:

- Alaska Native youth,
- African-American youth,
- Pacific Islander youth, and
- Mixed Race youth.

DMC exists throughout the Alaska juvenile justice system. In general, the highest DMC rates are at:

- Arrest,
- Detention,
- Diversion from court, and
- Petition to court



What is the System doing about DMC?

The Alaska Division of Juvenile Justice (DJJ) and the Alaska Juvenile Justice Advisory Committee (AJJAC) are working to reduce DMC by:

- Developing a data-based understanding of how DMC is created in Alaska and how it can be reduced,
- Increasing statewide DMC reduction efforts through public education, staff training, and system improvements,
- Supporting community-based DMC reduction activities, including research, public education and direct services to minority youth,
- Accessing the DMC reduction resources of the federal Office of Juvenile Justice and Delinquency Prevention, and reporting to that agency annually on Alaska's DMC reduction achievements,
- And ... asking you to join the DMC reduction effort.
