# INTRODUCTION

This publication provides detailed information on the operating grants awarded by the Department of Family and Community Services (DFCS) in Fiscal Year 2026. Through these grant programs, the department partners with approximately 38 agencies across the State to provide a variety of services such as placement care shelters, adoption and guardianship services, contact and protection settings that provide stable and secure environments for vulnerable children and families.

In Fiscal Year 2026, the department awarded almost \$9 million through grants and managed over 45 operating grants. Details provided for each grant program include a brief narrative, Results Based Budgeting Framework, grantee name, services area, fund source, and award amount.

Also, included in this publication is a DFCS Regions map providing a graphic description of the regions adopted by the department, which helps assess distribution of services and resources across the state. Lastly, an Election District report is included to delineate grant services provided in each election district. Grant programs are managed collaboratively with each of the department's divisions and Management Services, Grants Section. We welcome your suggestions and any recommendations you may have on how best we can address and respond to the needs of Alaskans and improve our services through our grant programs.

## Crisis Services Institutional Readiness

**Granting Authority:** 7AAC 78 - Grant Programs

**Description of Services:** The grants enable community-based organizations to become a facility-based crisis service center certified to provide services in the least restrictive environment. Services can be provided 24-hours a day, seven days a week, 365 days a year to all individuals (adults and children) presenting a mental health crisis. Because no two organizations are exactly alike and needs will differ, the grant is flexible to the kinds of costs be covered and includes (but not limited to):

- staff training
- 23-hour recliners
- crisis triage beds (non-ligature)
- safety improvements to facilities
- medication safes
- construction of walls to ensure individuals under 18-years of age are not housed with adults
- staff time to coordinate any needed subcontracts (e.g., with a commercial kitchen for patient meals; with telehealth medical
- providers should on-site staff not be able to provide for more complex medical or psychiatric needs)
- non-ligature furniture and clothing
- Narcan in preparedness for possible overdose

**Assessment of Need:** The current system relies on law enforcement, emergency medical services, and hospital emergency rooms to serve people in behavioral health crisis on civil commitment, which is largely outside of their scope of training. Increasing the availability of crisis stabilization services across Alaska allows law enforcement to focus more on crime prevention and other law enforcement activities.

Because not all individuals experiencing a mental health crisis or subject to a civil commitment have insurance, this funding reflects the costs associated with those individuals who are not covered by private insurance or Medicaid but require services through a crisis services facility.

<b>Description of Services:</b>	<p>There is to be a partnership established with hospitals (Designated Evaluation &amp; Stabilization (DES) and Designated Evaluation &amp; Treatment (DET) facilities) and a non-profit organization to help those people that are involuntarily committed and/or are unable to pay for the stay. These grants recognize costs incurred by DES and DET facilities not captured in the rate setting to carry out this work on behalf of the State. The hospital will follow the rules set forth in regulation and as explained in the "State of Alaska Designated Evaluation &amp; Treatment (DET) Program Manual." The general facility description of services is as follows:</p> <ol style="list-style-type: none"><li>1. Staff members receive training to develop appropriate interactions with patients.</li><li>2. Properly trained and qualified staff handle the protection, security, and observation of patients.</li><li>3. Children under 18 years of age do not share a room with adults.</li><li>4. Discharge plans are initiated early in the evaluation or treatment process and the facility provides stabilization, establishes diagnoses, and initiates care with the goal of permitting the patient's early return to the community for follow-up care. Discharge planning at an evaluation facility includes determining whether a patient should be released or transferred to a treatment facility and whether the patient needs mediation.</li><li>5. Treatment is individualized and as necessary and the administrator shall hire or contract with staff to deliver necessary specialized care.</li><li>6. Subject to the disclosure restrictions of 42 CFR Part 2, for a patient who is also receiving treatment for alcohol or drug abuse at a facility that receives federal financial assistance as described in 42 CFR Part 2 and the local community mental health center or other after-care agency is notified within 48 hours if a client from that center or agency, or an unassigned patient, is admitted for care, after obtaining a release for this notification from the patient.</li><li>7. A determination is made as to whether a patient is a candidate for placement and monitoring in the community's local crisis respite program and, if that is the case, ensure that the patient is placed in that program as soon as possible.</li><li>8. Make reasonable efforts to determine if the patient has preferences or instructions for their care by consulting with the patient, the patient's health care provider, the patient's spouse or parent, a person in the patient's household, or a person designated by the patient (7 AAC 72.085).</li></ol> <p>Currently, the DES/DET facilities meet with the Disproportionate Share Hospital (DSH) Health Program Manager monthly. An additional column will be added to their tracking that indicates the facility that received grant funds and the amount of the funds. The DSH Health Program Manager will maintain those records. Funds will be paid on a one-time basis.</p>
<b>Assessment of Need:</b>	The State of Alaska has a great need for psychiatric services. The current fiscal year estimate for transports alone to DES/DET facilities will be over 1000.
<b>Service Delivery Area:</b>	<p>Statewide</p> <p>The DES/DETs that will be eligible for grant funds are those located in Fairbanks, Juneau, Mat-Su and Ketchikan Borough areas, as well as any new providers who are designated as DES or DET facilities.</p>

# JUVENILE JUSTICE





## Federal Formula Non-Secure Attendant Care Shelter

<b>Granting Authority:</b>	7AAC 78 - Grant Programs, AS 47.05.010(7), AS 47.14.010(6)
<b>Description of Services:</b>	Non-secure attendant care shelters provide short-term staff-secure placement for referred youth and youth placed into protective custody until they can be safely released to a parent/guardian or transferred to a residential or juvenile detention facility. Referrals are made by the Division of Juvenile Justice's (DJJ) juvenile probation officers, by local judicial and law enforcement officers, as well as by schools. Shelter attendants provide one-to-one, same gender supervision to referred youth in staff-secure settings. Shelter service is available 24 hours per day and is provided within 45 minutes of notification of need. Shelter placements may not exceed 16 hours unless an extension is authorized. Agencies will use funds under the Grant Agreement to pay for limited administrative and operating costs associated with program readiness. As a condition of receiving an award, the provider will also enter into a Provider Agreement. The State of Alaska will utilize Provider Agreements to pay for the cost of services provided to the youth.
<b>Assessment of Need:</b>	The Federal Formula Grant Program makes funds available to states to improve juvenile justice systems and implement delinquency prevention and intervention strategies as mandated in the Juvenile Justice and Delinquency Prevention Act. In FY89, DJJ began using a portion of its Formula grant to support a statewide network of non-secure shelters. A strong and viable statewide system of non-secure shelters has been instrumental in reducing violations of the first three core mandates by providing temporary placement for youth placed in protective custody.

## Formula Title II Grant Program

<b>Granting Authority:</b>	7AAC 78 - Grant Programs, AS 47.14.010(6) General Powers of Department over Juvenile Institutions; AS 47.05.010(7) Duties of Department.
<b>Description of Services:</b>	Program services consist of the solicitation and administration of pass-through sub-awards. Administration includes technical assistance to communities in post-award project development, grant management, and reporting. Direct services are sub-awarded to Alaska Native tribal partners in rural communities. Through positive, culturally based youth development projects, at-risk youth gain self-worth, a sense of belonging, and community and cultural membership.
<b>Assessment of Need:</b>	Services are necessary to the State's adherence to core mandates of the Office of Juvenile Justice and Delinquency Prevention (OJJDP). Alaska Native youth are disproportionately referred to the Division of Juvenile Justice: 38% of all referrals, though only 17.2% of the statewide population. With prevention services, Alaska Native youth referral rates are reduced, as is the degree of disproportionate minority contact. The program further meets the division's intention to work effectively with tribal partners in support of cultural and community-based delinquency prevention projects supporting at risk youth.
<b>Service Delivery Area:</b>	Program services will be provided statewide.

<b>Description of Services:</b>	Program services include case screening, adjudication, disposition, and case management for youth who are referred for non-violent first or second time misdemeanor offenses, and/or status offenses. Cases are tried with representation and adjudication by the defendant's peers. Referral sources are DJJ field offices, local school districts, and District Courts.
<b>Assessment of Need:</b>	The program's early intervention and diversion services supplement and broaden the range of accountability-based restorative justice services for youth. Benefiting victims and communities, program services allow for the swift application of graduated responses, proven to be effective in preventing, controlling, and reducing further delinquent behaviors.
<b>Service Delivery Area:</b>	Statewide Resources will be allocated based on demonstrated need for services as supported by available data.

## Adoption and Guardianship Home Studies for Resource Families

<b>Granting Authority:</b>	7AAC 78 - Grant Programs Federal Adoptions and Safe Families Act (ASFA, 1997), AS 25.23.100 - AS 25.23.150 and AS 47.10.080 - 10.088
<b>Description of Services:</b>	Services are assessment of individuals or families identified as permanent homes for children in the custody of the Office of Children's Services (OCS). Assessments, or home studies, consist of background checks, home visits, interviews with each family member, interviews with collateral sources and references. The assessment also helps the family assess its own readiness and motivations for adoption/guardianship, while providing education and preparation. All assessments are reviewed for approval by OCS regional permanency staff.
<b>Assessment of Need:</b>	Office of Children Services (OCS) is required to complete a home study when a home is identified as a potential permanent placement and prior to the finalization of an adoption or guardianship of a child in care. <b>Description of Services:</b>	<p>Children's Advocacy Centers (CACs) help to identify maltreated children and protect them from further harm. CAC's provide referrals to treatment and follow up, hold offenders accountable, and provide community outreach and education regarding child abuse. A comprehensive, child-centered response in suspected cases of child abuse includes the coordinated efforts of a multidisciplinary team (MDT) including law enforcement, district attorneys and the assistant attorney general's office, child protection, victim advocates, as well as mental and medical health professionals.</p>
<b>Assessment of Need:</b>	<p>Centers accept referrals of suspected sexual abuse and other severe abuse of children up to age 18. Most also accept referrals of developmentally disabled young adults and those with cognitive impairments such as Fetal Alcohol Spectrum Disorder.</p> <p>Referrals continue to increase due to the State's broad support for effective CACs and increased community awareness regarding child abuse and child sexual abuse. Current centers are stable but not self-sustaining. This will also offer some cost savings to CACs currently serving children from outside the center's locale.</p>

## Post Adoption and Guardianship Support

**Granting Authority:** 7AAC 78 - Grant Programs

**Description of Services:** This program will provide post-adoptive and guardianship support services to include general resource and referral information for adoptive and guardianship families, adoptive/guardianship family support groups, connection to advocacy networks, mini-grants for therapeutic needs, and an optional innovative service to enhance post-adoption/guardianship services in Alaska. While services are open to all adoptive or guardianship resource families in Alaska, most served will be families who have adopted or become guardians of a child from the Office of Children's Services (OCS) foster care system. This grant program was formerly known as Services for Adoption Support.

**Assessment of Need:** The program's target populations are post-adoptive/guardianship resource families. Families who have adopted or entered a guardianship with children from Office of Children Services (OCS) have special parenting needs due to their children's history of experienced trauma. Children adopted from foster care have history of experienced physical maltreatment and/or neglect and often struggle with feelings of abandonment and grief over the loss of their birth families. Many children who have been adopted have a significant level of special needs, for which adoptive and guardianship families need support. Families often need services which are sensitive to the issues adoption and guardianship families face. Families who have adopted children from other states as well as privately through domestic or international adoption agencies, may also face special challenges. The program meets Department needs for post-adoption support.

Based on data in the Online Resources for Children of Alaska (ORCA) database, at the end of State Fiscal Year 2023, there were 4,217 children in Alaska's subsidized adoption and guardianship program. In FY23, OCS finalized a total of 404 adoptions and legal guardianships for children in foster care.

## Resource Family Training

<b>Granting Authority:</b>	7AAC 78 - Grant Programs, Federal Title IV B Sub-part II, Federal Title IV-E training, AS 47.32.030 (E) Powers and duties of the department, delegation to municipality and 7 AAC 50.250 Orientation and training
<b>Description of Services:</b>	The program provides a point of initial inquiry and contact for prospective resource families in Alaska. Services consist of planning, developing and implementing on-site and distance trainings for Office of Children's Services (OCS) resource families. Trainings utilize self-study packets, video and audio tools, on-line resources and teleconferencing. Culturally appropriate training and support of rural resource families via Indian Child Welfare Act Workers or other community members identified by Tribes and OCS staff is strongly emphasized. Intensive preparation services consisting of one-on-one education, family preparation classes, and matching support for families committed to special needs adoption will be provided in the Southcentral and Anchorage regions only. The program provides, to foster parents in every Resource Family home, accessibility to training to meet minimum annual requirements established by 7 AAC 50.250(g). Program services also include administration of the Resource Family Advisory Board.
<b>Assessment of Need:</b>	The program's target populations are Alaska's current and potential Resource Families providing foster and kinship care and/or pursuing adoption of children in out-of-home placement under OCS custody. The program meets the Office of Children's Services need for recruitment, training, individualized training plans and support of a continuous pool of safe, stable, trained and culturally appropriate families with which to place children in State of Alaska custody. At the end of calendar year 2022, there were 2,787 children in out-of-home placement. Additionally, at the end of 2022 there were 1,784 OCS licensed foster homes in Alaska, 1,259 of which were non-child-specific. Due to the continued increase in number of children in need of out-of-home placement, the Department anticipates a higher demand for new Resource Families as well as for training and support for existing Resource Families.

## Youth Interim Services

**Granting Authority:**

7AAC 78 - Grant Programs,

Program Services are authorized under 7 AAC 78 Grant Programs and includes the following governing statutes:

**Description of Services:**

The primary goals of the Youth Interim Services (YIS) grant are: Youth behavioral stabilization, Behavioral health screening, Human trafficking screening, Support youth emergent needs in times of crisis, Assist youth in participation of scheduled court appearances (if applicable), Provide/ Assist in the coordination of medical and mental health treatment, Provide supervision of medication management and delivery, Develop or assist in the creation and delivery of youth transition plan out of shelter, Coordination with community resources as needed to meet the needs of the youth.

**Assessment of Need:**

There is a known population of youth that leave foster homes and require shelter. This population may be impacted by trauma and therefore not prepared for a family setting, and choose to go to a shelter instead. These youth require other case management services such as job search assistance, educational assistance, and coordinated services in order to stabilize and transition into a family setting.

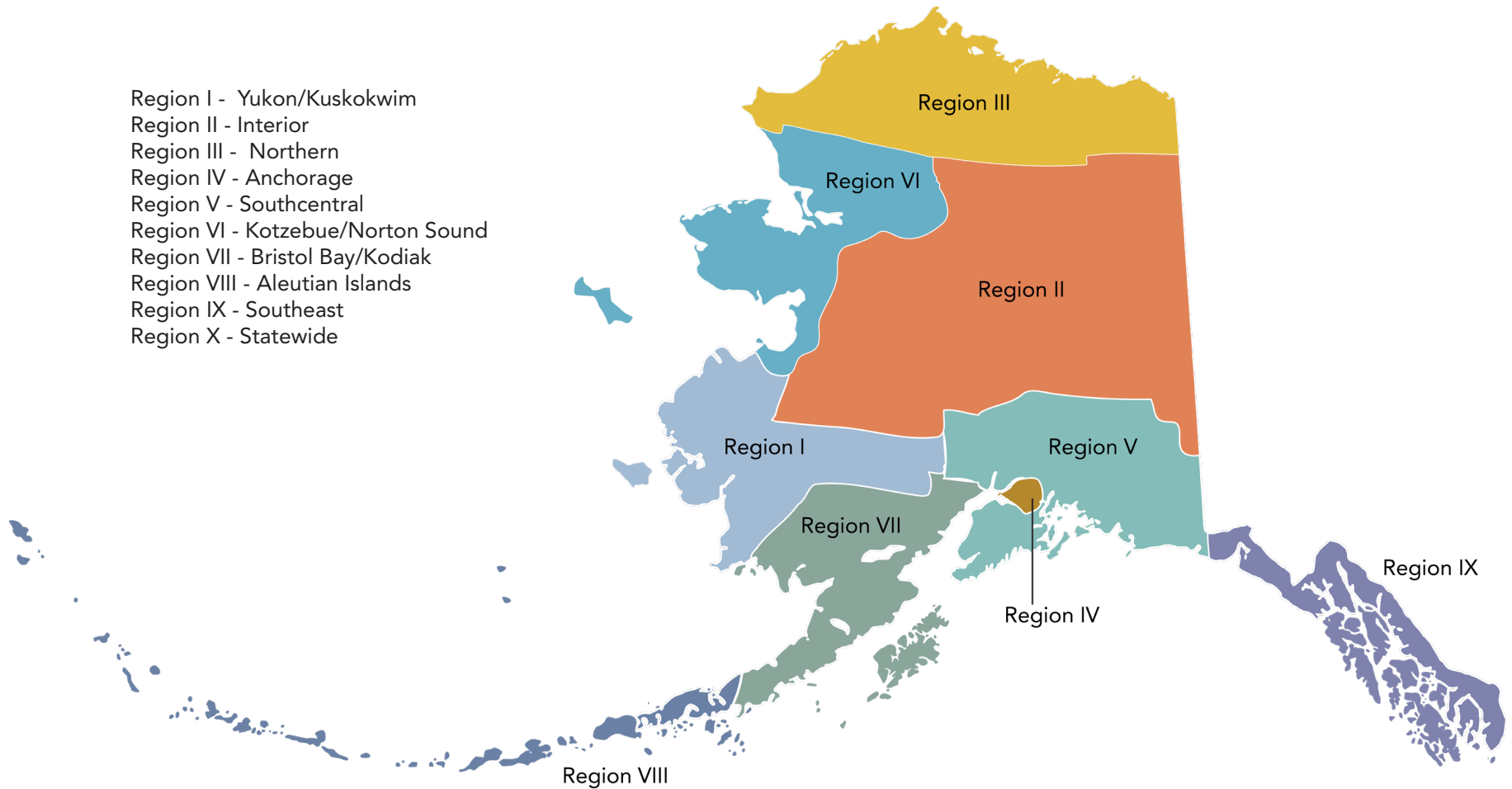
