\*\*Below is an example of a card laminated front and back available to law enforcement officers in Alaska to be used as an interview tool during investigations.

## **Strangulation Questions**

- 1. How was the victim strangled (one or two hands, right or left hand, forearm or object)? If ligature, what was it and where did suspect obtain it?
- 2. How many times during the incident was the victim strangled? Describe in detail each incident.
- 3. Was the victim also shaken?
- 4. Was the victim's head pounded against anything?
- 5. Did the suspect say anything while strangling the victim?
- 6. What did the victim think was going to happen? (For example, "I thought he was finally going to kill me.")
- 7. What did the victim say to the suspect? (For example, "Stop it! Let go! I can't breathe.")
- 8. How long did the strangulation last?
- 9. On a scale of 1-10 how much pressure did the suspect apply and how much did it hurt?
- 10. How or why did it stop (arrival of police, intervention of witness or victim passed out)?
- 11. How did the victim feel (faint, dizzy, difficulty hearing or lose consciousness)?
- 12. Did the victim have: a raspy voice, difficulty breathing, complaints of pain to throat or neck, coughing or trouble swallowing?
- 13. Did the victim vomit, urinate or defecate as a result of being strangled?
- 14. Did the victim attempt to defend herself? (Describe)
- 15. What was the suspect's demeanor?
- 16. Does the victim have any injuries (petechiae, bruising, lacerations, abrasions, etc.)?
- 17. Did the suspect force the victim to have sex?

## Remember

- 1. Document any prior incidences of strangulation.
- 2. Contact EMS and encourage victim to seek medical attention.
- 3. Obtain medical release.
- 4. Photograph and document all visible injuries (however minor) and/or areas in which victim/suspect complains of pain.
- 5. Locate and seize object used and determine if brought to the scene by the suspect.
- 6. If the victim is wearing make-up, take photos with make-up on and then photos after having victim remove make-up.
- 7. Take follow-up photographs of the victim's injuries.

## **Lethality Questions**

If victim answers yes to any of the following questions, you should elicit as much information from the victim as possible including dates, witnesses and a detailed account of the event(s). Threats made by suspect should be placed in "quotes."

During the course of your relationship has your partner: (Partner refers to any of the "household" relationships defined in AS 18.66.990).

- 1. Become increasingly violent, brutal or dangerous to you?
- 2. Caused injuries to you that required medical attention?
- 3. Strangled ("choked") or suffocated you?
- 4. Threatened to kill you or any of your family members?
- 5. Threatened or attempted to commit suicide?
- 6. Forced you to have sex when you did not wish to do so?
- 7. Threatened you with a weapon (gun, knife, object, etc.)?
- 8. Assaulted you while you were pregnant?
- 9. Harmed or threatened to harm any of your children?
- 10. Violated a DVPO (Restraining or Protective Order)?
- 11. Threatened you when you sought or attempted to seek help from the police or the courts?
- 12. Threatened you or forced you not to cooperate with police, the prosecution or the courts?
- 13. Made any threats toward police?

- 14. Does your Partner own a gun or have access to a gun?
- 15. Do you think your partner may seriously injure or kill you? If yes, why and if no, why not?
- 16. Is your partner violently jealous about you? Does your partner say, "If I can't have you, no one can?"
- 17. Does your partner control most of your daily activities?
- 18. Does your partner tell you whom you can be friends with, when you can see your family, how much money you can spend or when you can take the car?
- 19. Does your partner follow or spy on you (stalking)?
- 20. Does your partner ever use drugs? Is your partner drunk every day or almost every day?
- 21. Have you separated or tried to separate from your partner in the past year?
- 22. Do you feel isolated from sources of help (family, friends, car, phone, etc.)?
